POSITION SUMMARY

The Nurse Practitioner (NP) will function as a member of a multidisciplinary team, providing the full scope of primary health care nurse practitioner services. The Nurse Practitioner will collaborate with health care professionals, allied health services, community services and agencies.

Applies current nursing and medical theory to the provision of care, autonomously ordering and interpreting diagnostic tests, pharmacologic agents and performing minor invasive procedures and in the implementation of strategies to promote health and prevent illness and exercises proficiency in planning, implementing, and evaluating complex care.

The NP applies current/relevant nursing and medical theory to allow for the contribution of knowledge, development, and involvement in advancing the principles of primary health care. The incumbent also demonstrates competency to teach and mentor others and models' collaborative practice.

The incumbent will exercise the appropriate level of initiative and independent judgment in determining work priorities, work methods to be employed and action to be taken on unusual matters. The position functions in a manner that is consistent with the mission, vision, and values; and the policies of the Ginew Wellness Center.
